Full Membership open to individuals, partnerships and companies who shall be entitled to register a flock or individual sheep in the Society's Flock Book, have one vote at Society General Meetings (in the case of partnerships or companies a named individual notified to the Society in writing on joining or subsequently amended in writing), stand for election to the Society's Council and Judging Panel, receive Society communications and partake in Society events.

Annual Fee £35 + VAT

Associate Membership open to individuals only who shall be entitled to one vote at Society General Meetings, stand for election to the Society Council and Judging Panel, receive Society communications and partake in Society events.

Annual Fee £25 + VAT

Junior Membership open to individuals who have not attained the age of 18 years on 1st January in the year of Membership who shall be entitled to register a flock or individual sheep in the Society Flock Book, have one vote at Society General Meetings, stand for election for Society Council and Judging Panel, receive Society communications and partake in Society events.

Annual Fee £15 + VAT

The annual subscription shall be payable on 1st January in every year, unless the Member who would otherwise have been liable to pay the same shall give 3 months notice, in writing, before that date of his/her intention to withdraw from the Society.

In addition:-

Each Full and Junior Member shall declare his or her or their flock on an annual Flock Return issued from time to time by the Society (but not more than once in any calendar year) the true numbers of pure ewes and rams in the flock together with ewe lambs and ram lambs intended to be retained for breeding and pay on demand to the Society a Ewe Levy (currently 10p+VAT) for each and every ewe and shearling ewe declared on the Flock Return at a fee from time to time determined by the Devon Closewool Sheep Breeders Society Council.
